- (1) Document Verification cum Seat Acceptance Letter received from reporting center.
- (2) Printout of current seat allotment
- (3) Proof of payment of fee paid by the candidate to NIT-Raipur.(other than SC/ST/PWD)
- (4) Aadhar Card
- (5) Filled-in Admission Form (Format attached as **Annexure-I**).
- (6) Admit Card of JEE(MAIN) 2020 & Score Card of JEE(MAIN) 2020
- (7) Class X (High School) Board Certificate as proof of date of birth
- (8) Pass Certificate and Marks sheet of qualifying examination (class XII)
- (9) Certificate of OBC-NCL/SC/ST category by the competent authority in the prescribed format.
The OBC-NCL certificate should be dated on or after April 1, 2020. The certificate should clearly mention that the candidate belongs to non-creamy layer and the caste of the candidate must be in the state-wise central list of OBCs given at http://www.ncbc.nic.in/User_Panel/CentralListStateView.aspx
- (10) Certificate for Persons with Disabilities (PWD) in the prescribed format, if applicable.

(17) Income certificate issued from competent authority (e.g.DM/DC/SDM/SDO/Tahsildar) for the Gen and OBC candidate claiming for the remission of tuition fees for the latest financial year. Income certificate must be issued on or after 01/04/2022. Without annual income certificate, student will not be given remission of tuition fee.
