Agenda 32.3 To consider and recommend the construction of G+6 structure in place of the existing Unit Operation Lab of the Institute with an estimated cost of Rs. 25,57,11,476/-.

Resolution: After deliberation, the BWC recommended the proposal of Rs. 25,57,21,447.00 (Twenty-Five Crores Fifty-Seven Lakhs Twenty-One Thousand Four Hundred and Forty-Seven Rupees Only) to the Finance Committee for construction of G+6 structure in place of the existing Unit Operation Lab of the Institute.

Agenda 32.4 To consider and approve various civil works in Mahanadi Girls' Hostel (Hostel-E) with an estimated cost of Rs. 11.90.109/-

Agenda 32.6 To consider and recommend construction of additional rooms to increase accommodation capacity and extension of mess hall in Mahanadi Hostel with an estimated cost of Rs. 78,58,103/-.

The BWC was apprised that because of increase in the number of girl students due to the creation of additional supernumerary seats in the institute, there is an acute shortage of space in the mess hall and hostel accommodation for girls. Hence, an urgent need for additional mess halls and living halls is felt.

The BWC after due deliberation recommended the proposal of Rs. 78,58,103/- (Seventy-Eight Lakhs Fifty-Eight Thousand One Hundred and Three Rupees Only) to the Finance Committee for extension of Mess Hall in Mahanadi Hostel and construction of an additional hall above it to increase the accommodation capacity of Mahanadi Hostel.

To consider and approve Rs. 6,19,153/- for shifting of High Voltage 33KV electric line passing over Sewerage Treatment Plant.

The BWC approved the proposal of Rs. 6,19,153/- (Six Lakhs Nineteen Thousand One Hundred and Fifty-Three Rupees Only) for shifting of High Voltage 33KV electric line passing over Sewerage Treatment Plant.
