Resolution:	The construction of a light weight temporary shed for Chemistry Lab and Physics Lab at the Cycle Stand Ground at an estimated cost of Rs. 79,84,193/ was recommended by the BWC to be carried out under the budget sanctioned under Head-35. The construction of proposed structure will be done on the basis of open tender to be floated by the Estate Office of the Institute.	
Agenda No. 36.4	To consider and recommend the temporary construction of two large rooms for academic purposes at the space adjacent to Makerspace at an estimated cost of Rs. 79,63,997/	
Resolution:	The temporary construction of two large rooms for academic purposes at the space adjacent to Makerspace at an estimated cost of Rs. 79,63,997/- was recommended by the BWC to be carried out under the budget sanctioned under Head-35. The construction of proposed structure will be done on the basis of open tender to be floated by the Estate Office of the Institute.	
Agenda No. 36.5	To consider and recommend the additional cost of Rs. 48,19,17,000/- for construction of four floors of the Academic Annex Building with total Carpet Area of 6400 Sq. Mt. and Built-up Area of 10293 Sq. Mt by CPWD vertically above the G+2 Classroom Building at the existing campus of NIT Raipur from the Corpus fund.	
Resolution:	The BWC recommend the additional cost of Rs. 48,19,17,000/-(based on CPWD-DPAR 2012 & then market rate) for construction of four floors of the Academic Annex Building with total Carpet Area of 6400 Sq. Mt. and Built-up Area of 10293 Sq. Mt by CPWD vertically above the G+2 Classroom Building at the existing campus of NIT Raipur from the Corpus fund. For CPWD DPAR based on 2021 now the revised cost is Rs. 52,45,24,400/-	
	Overall, the Building shall be G+6 of 17219.02 Sq M. Plinth area consisting of 26 classrooms and 2 dedicated floors of area 4919.72 SqM. for the library. The G+2 has already been approved under EWS. The preliminary estimate of G+2 for Rs. 29,90,34200/- has already been approved in 35 th BWC. Further, the same has been approved in the 51 st FC Committee meeting & 59 th BOG meeting dated 25.07.2023.	
	Out of Rs.29,90,34200/- The source of fund for the proposed Academic Annex Building will be: EWS Fund from MOE: Rs. 152033775 Rs.147000425/- from other sources	

,	And the remaining amount Rs. 52,45,24,400/- from the corpus fund of the Institute. As per policy for utilization of Corpus Fund - approved by the 41 st meeting of BoG on the recommendation of 36 th meeting of FC.
	Hence a total additional amount of Rs 52,45,24,400/- is recommended from the Corpus Fund.
Agenda No. 36.6	To consider and recommend the installation of a Grid connected roof top solar power plant of 700 kWp on the main building of NIT Raipur using RESCO (Renewal Energy Service Company Model).
Resolution:	The BWC recommended the installation of a Grid connected roof top solar power plant of 700 kWp on the main building of NIT Raipur using RESCO (Renewal Energy Service Company Model). The selection criteria for the agency shall be on the basis of lowest energy unit cost.
Agenda No. 36.7	Hostel and Guest House at the existing campus with an estimated cost of Rs. 131,57,40,300/- and the consolidated proposal for construction of New Campus of NIT Raipur at Rakhi Bharenga along with the proposal for Rs.
Resolution:	Hostel, Girls Hostel and New Guest House at existing Campus of NIT Raipur. The BWC noted the withdrawal of proposal for construction of Girls Hostel, Boys Hostel and Guest House at the existing campus with an estimated cost of Rs. 131,57,40,300/
